# 6.0 Key Standards of Business Conduct with Suppliers:

# 6.1 Family Members Doing Business with Tark Thermal Solutions Employees

6.1.1 Tark Thermal Solutions employees may not engage in transactions on behalf of the company with suppliers who are family members or have a substantial beneficial interest where they serve as a trustee or in a fiduciary capacity.

# 6.2 Suppliers must sign Tark Thermal Solutions Non-Disclosure Agreement (NDA)

6.2.1 A prerequisite to doing business with Tark Thermal Solutions is accepting and signing a copy of our NDA as well as other relevant required commercial agreements. This document must be signed and agreed before any confidential technical or business information can be exchanged between companies.

#### 6.3 Business Awards and 'Kickbacks'

- 6.3.1 Tark Thermal Solutions treats all potential suppliers fairly, openly and considers all interested/qualified suppliers when we purchase goods or services based on their ability to meet our business needs. We demand fair, transparent negotiation and bidding processes, conducted in the utmost professional manner when working with our procurement and sourcing representatives.
- 6.3.2 Under no circumstances are suppliers allowed to offer 'kickbacks' or rebates to try to entice a Tark Thermal Solutions employee to choose a supplier nor should any employee of Tark Thermal Solutions request such treatment from you in order to earn our business. A kickback refers to any money, fee, commission, credit, gift, gratuity, or item of value or compensation of any kind, which is provided, directly or indirectly, for the purpose of improperly obtaining or rewarding favorable treatment in connection with a contract or relationship from Tark Thermal Solutions.

#### 6.4 Business Gifts

6.4.1 Please be aware that all Tark Thermal Solutions employees are required to adhere to strict policies related to gifts and entertainment with suppliers.

# 6.5 International Corruption Law

6.5.1 Our employees are required to abide by international good practice in these matters e.g., the U.S. Foreign Corrupt Practices Act (FCPA) and UK Anti Bribery Act 2010. We expect our suppliers to abide by these same regulations and any other applicable local laws relating to bribery and corruption.

# 6.6 Counterfeit Components Usage

6.6.1 Tark Thermal Solutions is taking action to increase awareness and controls in our supply chain in order to prevent counterfeit components from entering our production processes. We expect our suppliers to implement anti-counterfeit procurement measures and to ensure that they utilize only authorized suppliers and distributors. Tark Thermal Solutions reserves the right, from time to time, to audit its suppliers' preventive measures in this area.

# 6.7 Supply Chain Security

6.7.1 Tark Thermal Solutions is committed to assessing, managing, and improving its supply chain security. It is Tark Thermal Solutions intent to work with their business partners as a team to improve supply chain security practices. We expect your company will comply with the U.S. Customs "C-TPAT: Customs-Trade Partnership Against Terrorism" minimum security requirements. ### 6.8 Trade Compliance

Suppliers are required to adhere to all governmental trade compliance import and export regulations involving Tark Thermal Solutions shipments.

### 6.9 No Forced Labour, Slavery or Human Trafficking

# 6.11 Restricted Substance Compliance

6.11.1 Tark Thermal Solutions is dedicated to ensuring that our operations and products strictly comply with all applicable laws, regulations and customer requirements (including REACH and RoHS) regarding banned, restricted and reportable substances. Tark Thermal Solutions may from time to time issue specific guidance to its suppliers setting out Tark Thermal Solutions standards for banned, restricted and reportable substances within our products and packaging. In order to conduct business with Tark Thermal Solutions, suppliers are, upon request, expected to declare the material content of products delivered to Tark Thermal Solutions and to certify compliance with all requirements contained within applicable regulations and within any guidance issued by Tark Thermal Solutions or contained in purchase orders, drawings or purchased part specifications.

### 6.12 Human Rights in Minerals Mining in Central Africa (Conflict Minerals)

6.12.1 Human rights violations related to the trade in minerals from the conflict zones in the Democratic Republic of Congo (DRC) are a focus of Tark Thermal Solutions supply chain and environmental responsibilities. Tark Thermal Solutions requires its suppliers not to source materials defined in the Dodd-Frank Act and their derivatives (including gold, tin, tantalum and tungsten metals) from the conflict zones in the Democratic Republic of Congo (DRC). We expect suppliers to conduct their worldwide operations in a manner that does not result in labor or human rights violations, including operations that contribute to the direct financing of armed conflict. to support this requirement suppliers are required to establish due diligence processes consistent with published guidance in order to make it possible to verify whether conflict minerals are contained in products sold to Tark Thermal Solutions and to provide such information to Tark Thermal Solutions on request.

# 7.0 How to Report an Ethics Concern to Tark Thermal Solutions

7.1.1 To report a questionable behavior or possible violation of the Supplier Code of Conduct, Tark Thermal Solutions has a variety of resources available to assist you as our supplier. Suppliers are encouraged to work with their primary Tark Thermal Solutions contact in resolving a business practice or compliance concern. However, Tark Thermal Solutions recognizes that there may be times when this is not possible or appropriate. In such a situation the Supplier should report (see 7.2 below) their concerns to either the TTS Global Sourcing Director TTS.sourcing@Tarkthermal.com and/or the TTS HRD tts.hr@tark-solutions.com and/or to TTS legal team legal.support@tark-solutions.com.

# 7.2 Reporting of Questionable Behavior and/or Possible Violations

- 7.2.1 When reporting a concern, suppliers or vendors should indicate that they are reporting on behalf of "Tark Thermal Solutions" rather than their supplier company name.
- 7.2.2 Provide specific information about which Tark Thermal Solutions site or organization is associated with the concern.
- 7.2.3 Your concern will be held in complete confidence, and you can remain anonymous if you choose. However, providing contact information will help us investigate your concern.
- 7.2.4 Tark Thermal Solutions will not tolerate any retribution or retaliation taken against any individual who has, in good faith, sought our advice or has reported questionable behavior and/or a possible violation.
